### [The End of Life Option Act... What Is It & What Is Going On With It?](#)

The [End of Life Option Act](#) was signed on October 5, 2015 by Governor Jerry Brown. An August 2015, [UC Berkley](#) and an October 2015, [Stanford University](#) poll showed 72.5%--76% of Californians supported the End of Life Option Act. The law went into effect on June 9, 2016. California is one of only 7 states (Colorado, Hawaii, Montana, Oregon, Vermont and Washington plus Washington, DC) that allow doctors to prescribe lethal prescriptions for terminally ill patients. Since the law went into effect about 193 prescriptions for the drug have been made and 111 deaths have taken place as [reported](#) by California Department of Public Health.

However, on May 15, 2018 Judge Daniel Ottolia issued an [oral ruling](#) stating the California [End of Life Option Act](#) was passed illegally. On May 22, 2018, Attorney General Xavier Becerra filed an appeal. On May 25, Judge Ottolia issued a formal written [ruling](#) confirming the law is void as unconstitutional. The law is [suspended](#), and cannot be utilized until the appeal is heard, which could take months.

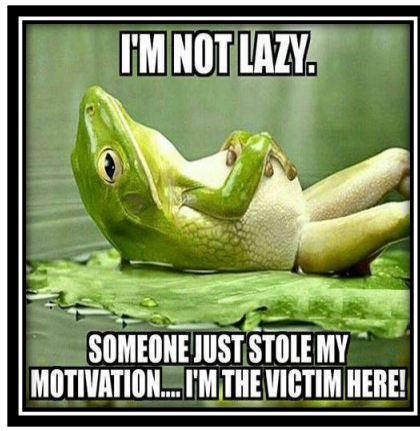
